Micro, small and medium enterprises (MSME) based Malayalee entrepreneurs are the potential members of the Chamber. Non-malayalee entrepreneurs can also be admitted as members. Various categories of memberships can be finalized through consultations.

The following suggestions were also made in the meeting

- KDS may prepare a detailed proposal covering various aspects of the proposed chamber including technical and financial aspects.
- Young entrepreneurs shall be one of the main beneficiaries of the proposed chamber.
- More consultation meeting are to be held before the registration of the chamber
- The proposed chamber should not be duplication of existing chambers. The new chamber should be new generation are in line with the new technologies emerging business needs and changing policy environment.
